REVIEW BOARD POLICY 7:40 RECOMMENDATION

Dr. Wroblewski updated the committee on the recommendations for the requirements for Students-Nonpublic School Students, including Parochial and home-schooled student wishing to participate in both athletic and/or non-athletic extracurricular activities must be enrolled at LPHS for 4 classes each semester to participate. Discussed assigning the Associate Principal for Teaching and Learning to evaluate and approve the Home-school curriculum. Parent will submit a current weekly/semester grade reports for their student. Home-school student enrolled at L-P to participate in either athletics or non-athletic extracurricular activities must commit to staying enrolled for the entire year.
